

# WEEKLY COMMENTARY 24.04.2021

## **U.S. Equities**

US equities finished the week slightly lower, as continued good earnings reports were not enough to offset a report by Bloomberg that President Biden intended to keep a campaign promise and raise the capital gains tax on those making a million dollars or more.

The Dow Jones fell 0.5% to 34,043.49, the S&P 500 slipped 0.1% to 4,185.47 and the Nasdaq finished the week down 0.3% to 14,016.81.

#### **Treasuries**

Like equities, Treasury yields slipped slightly on the week. The 10-year Treasury bond yield declined by 0.5 basis point, the 2-year note yield slipped by 0.6 of a basis point and the 30-year bond yield dropped by 0.9 of a basis point.

### **Dollar**

The ICE US Dollar Index continues to come under pressure as global economies recover from COVID-19. The dollar index is down 2.6% so far in April.

#### Gold

It was a mixed week for gold prices, as investors worries about inflation. After climbing to a near a two month high earlier in the week, gold prices fell, leaving them down 0.1% for the past five sessions.

#### Crude Oil

Concerns about rising COVID-19 cases in Japan and India kept a lid on oil prices last week. For the week, WTI saw a loss of 1.7%, while Brent was off 1%.
