



Fund Summary

The investment objective of the Sub-Fund is to generate capital growth from the equity market whilst maintaining in aggregate lower volatility relative to the broader US equity market.

The Sub-Fund is expected to invest mainly in the US equity market with focus on equities listed by issuers domiciled or with country of risk being the United States of America. In aggregate, the fund will seek for these investments to have lower volatility characteristics relative to the broader U.S. equity market. Up to 100% of the assets of the Sub-Fund may be invested in equities. The Sub-Fund is however not expected to have any specific industry, market capitalisation or market sector bias.

Manager Comment

The US economy continued to show signs of recovery and equities rallied in May despite the fear that inflation might cause the FOMC to raise rates earlier than expected. The lasted reading of personal spending, one of the FOMC's favorite inflation measures, neared a 13 year high and capped enthusiasm for equities. Neither the FOMC nor the Treasury markets seemed as concerned about inflation as stock investors. The FOMC remains committed to low interest rates and Treasury bond yields ended May lower that where they began the month, with the 10-year and 30-year bonds both posting their second straight month of losses. The 10-year benchmark yield hovered around 1.6% at month end.

The Castlestone Low Volatility Income UCITS fund turned in a positive performance in May. The fund's top performing sector over the month was material which was also the S&P 500's top returning sector in May. Newmont Corp returned 17.74% in May, helped by the rally in gold, making it Low Volatility's top stock for the month.
