

# WEEKLY COMMENTARY 29.05.2021

## U.S. Equities

Stock ended the week higher after another strong report on the economy was released. The personal-consumption expenditure index (PCE), the Fed's preferred measure of inflation, came in at a 13 year high of 3.6%.

The Dow Jones ended the week up 0.9% at 34,529, the S&P 500 rose 1.2% to 4,204 and the Nasdaq Composite rose 2.1% to 13,748. Stocks reacted positively to signs of a growing economy in front of the long weekend.

**Treasuries** 

Treasury bond yields fell over the week as the Biden administration announces an ambitious \$6 trillion budget proposal for fiscal year 2022. The 10-year bond rate fell 3.7 basis points last week, the 30 year bond yield slipped 6.1 basis points and the 2-year note dipped 1.2 basis points.

### Dollar

The ICE Dollar index ended the week about were it started but not before trading lower in the early part of the week only to rally on the PCE report.

### Gold

Gold prices rallied above the psychologically important level of \$1900 an ounce and recorded a 1.5% gain for the week.

### Crude Oil

Oil posted its biggest weekly gain since the middle of April ahead of the U.S. Memorial Day weekend that kicks off the country's summer driving season. WTI posted a 4.3% weekly gain.
