

WEEKLY COMMENTARY 18.09.2021

U.S. Equities

US equity markets reversed course on Friday after a weaker than expected consumer confidence number and erased any gains from the pervious four days. It's worth noting that Friday was a quadruple witch and option trading may be the reason for the sell off. On the week, the Dow Jones lost 0.1% to close at 34,584.88, the S&P 500 dropped 0.2% to 4,432.99, while the Nasdaq slipped 0.1% to 15,043.97.

Treasuries

Ahead of next week's Fed meeting, Treasury yields climbed. For the week, the 10-year yield hit 1.37% reaching its highest level since September 7th. The 2-year note yield closed at 0.224%, its highest yield since August 24th and the 30-year bond yield reached 1.90%, its highest level since September 10th.

Dollar

The ICE Dollar Index climbed over 93 and posted a weekly gain of 0.7%.

Gold

Gold prices fell for the second straight week, recording a 2.3% weekly drop.

Crude Oil

Oil prices broke out of their trading range last week, notching their fourth week of gains. The slow return of gulf oil refineries after hurricane Ida was given credit for the price rise. WTI scored a weekly gain of 3.2% and Brent rose 3.3%.
