

# WEEKLY COMMENTARY 05.14.2022

## **U.S. Equities**

The S&P 500 and Nasdaq both booked their sixth straight week of losses as inflation continues to climb and the war in Ukraine drags on.

The S&P fell 2.4% on the week, the Dow Jones slipped 2.1% and the Nasdaq Composite declined 2.8% to 11,805.

During the week the S&P traded below the all-important technical level of 4000 but so far seems to be holding that level.

#### Treasuries

The 2- and 10- year Treasury yields had their biggest one week decline since March as bond holders seem to have shifted their focus from inflation to slowing growth.

The 2-year note yield declined 9.9 basis points, the 10-year note yield fell 19.2 basis points and the 30-year bond yield posted a 12.9 basis points weekly decline.

### Dollar

The US Dollar index continued to strengthen, climbing 0.9% on the week. The dollar is hovering around a 20-year high.

### Gold

Gold prices fell to their lowest level in 14-weeks and posted their worst weekly performance in 11 months. The price of the precious metal was 3.9% lower for the week.

#### **Crude Oil**

Oil prices continued to move higher over the week despite slowing demand. WTI rose 0.9% and Brent prices increased by 0.8%.
