

WEEKLY COMMENTARY

U.S. Equities

The Dow Jones Industrial average posted its eighth straight down week. All three US averages recorded another week of losses as investors continue to worry the economy is nearing a recession.

For the week the Dow fell 2.9%, the S&P 500 dropped 3.1% and the Nasdaq slipped 3.8%. The S&P briefly entered bear territory on Friday before bouncing near the close.

Treasuries

Treasury bond yields fell for a second straight week with the 2- and 10- year Treasury yields recording their biggest two week drops in two years.

The 2-year Treasury note yield fell 1.6 basis points, the 10-year Treasury note yield dropped 14.7 basis points and the 30-year Treasury bond declined 9.7 basis points.

Fears of stagflation. A combination of persistent inflation and stagnant growth are on the rise and have been a key driver of both equity and bond markets.

Dollar

The US Dollar index posted a loss of 1.4% and continues to back off the 20- year high posted on May 12th.

Gold

Gold prices rose 1.7% on the week, reversing a four-week decline.

Crude Oil

Oil prices closed out another week with gains as concerns over tightening supplies worry the market. WTI climbed 2.5% and Brent rose 0.9% on the week.
