

# WEEKLY COMMENTARY

# **U.S. Equities**

Positive news, negative effects. A strong US jobs report sent stocks lower on the week. The Nonfarm payroll number was reported at 390,000, above expectation. This reaffirmed for investors that the Fed will need to keep raising interest rates.

The Dow dropped 0.9% to 32,899.70, the S&P fell 1.2% to 4,108.54 and the Nasdaq slipped 1% to 12,012.73 last week.

### **Treasuries**

Treasury yields posted their largest gains in a month as the jobs report confirmed interest rates are moving higher.

The 10-year Treasury yield climbed 20.7 basis points on the week, the 2-year yield advanced 16.9 basis points and the 30-year bond yield rose 13.5 basis points.

#### Dollar

The US Dollar index surged on the jobs report and finished the week higher.

# Gold

The surging dollar reversed a two week climb in gold, causing the precious metal to post a weekly loss of 0.3%.

## **Crude Oil**

Despite a decision by OPEC+ to pump more oil in July and August, both WTI and Brent posted weekly gains. The US benchmark rose 3.3% and Brent climbed 3.6% on the week.
