## FUND OBJECTIVE

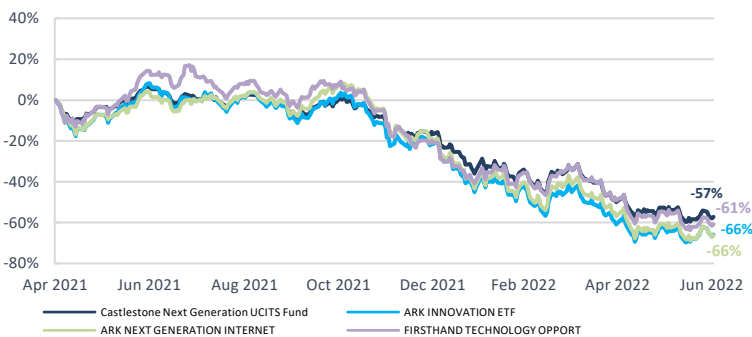

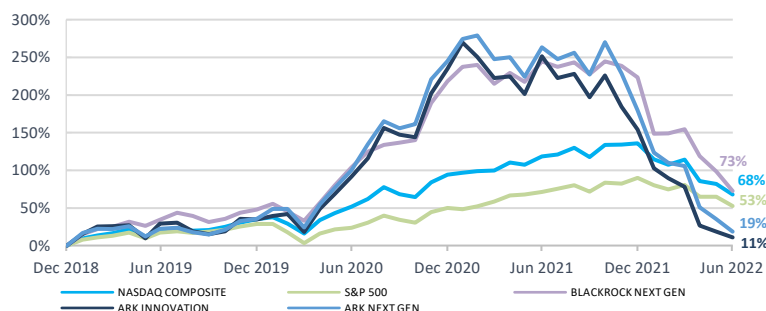
