

WEEKLY COMMENTARY 07.23.2022

U.S. Equities

A weak PMI number sent US stocks lower on Friday, but the three major US averages still managed to record gains.

Posting their highest weekly advance in a month, the S&P 500 briefly traded above 4000 for the first time since June 9th and closed 2.6%. The Dow Jones rose by 2% and the Nasdaq Composite climbed 3.3%.

Treasuries

Long-dated U.S. bond yields fell to their lowest levels in almost two months on Friday. Posting their second straight week of declines on growing concerns the economy could tip into recession.

The 10-year Treasury note slid 14.8 basis points, the 2-year note fell 14.6 basis points and the 30-year bond yield fell 9.7 basis points last week. All three closed below 3%.

Dollar

After reaching parity with the Euro, the dollar reversed direction and traded lower for most of the week.

The euro was up over 1% against the dollar over the last five trading sessions. The shared currency snapped three weeks of losses against the dollar.

Gold

Gold prices ended a five-week losing streak on what looked like dip buying. Prices climbed 1.4% for the week but gold still looks to be in a downward trend as Treasury yields rise.

Crude Oil

US oil prices began to show signs of demand destruction as the summer driving numbers appeared lower than expected.

However, WTI futures for August posted a weekly gain off 0.1%, while the global benchmark climbed 2%.
