

# WEEKLY COMMENTARY

# **U.S. Equities**

All three major US averages recorded weekly declines. A series of economic reports showed the US economy is running hotter than the Federal Reserve would like.

The Dow Jones slipped 2.8%, the S&P 500 fell 3.4% and the Nasdaq Composite declined 4% to 11,004.62.

# **Treasuries**

Bond yields posted weekly gains as inflation in the US remains well above the Fed's targeted 2% level.

The 10-year Treasury yield climbed 6.5 basis points, posting its biggest weekly rate gain in five weeks. The 2-year note yield advanced 5 basis points, while the 30-year bond yield declined less than 1 basis point on the week.

#### Dollar

The US dollar finished the week with a slight gain but lost upside momentum as the week progressed.

### Gold

Gold prices finished the week largely unchanged, up 0.1% over five days of trading.

# **Crude Oil**

Oil prices ended the week down 11%, their largest weekly loss in eight months. WTI slid 11.2% and Brent dropped 11.1% as traders worried that global economic conditions might be worsening.
