

WEEKLY COMMENTARY 12.17.2022

U.S. Equities

All three major US averages booked back-to-back weekly declines for the first time since the end of September as global central banks raised interest rates in the face of weakening US economic data. The Dow Jones dipped 1.7% to 32,920.46, the S&P 500 dropped 2.1% to 3,852.36 and the Nasdaq Composite lost 2.7% to 10,705.41 on the week. Friday's option expiration exaggerated the losses.

Treasuries

Despite a 50-basis point increase in interest rates this week, Treasury yields moved lower, led by the 2-year note. The 2-year Treasury yield declined 14.8 basis points on the week, the 10-year note yield fell 8.6 basis points and has been down five of the last six weeks. The 30-year bond yield closed out the week down 1.7 basis points and is lower for a sixth straight week.

Dollar

The US dollar index finished a volatile week lower against a backet of currencies.

Gold

Gold prices were volatile during the week, climbing to a nearly six-month high before posting a weekly decline. The yellow metal was down 0.6% on the week.

Crude Oil

Oil prices bucked the weekly trend and finished up on the hopes of a China reopening. WTI posted a 4.6% weekly gain and Brent was up 3.9%.
