# **U.S. Equities**

Economic data released last week continues to demonstrate the Fed's rate hiking policy is slowing the economy while employment and spending remain stable.

The brighter outlook is offsetting a mixed start to earnings season and helping to lift the major averages. The Dow Jones has booked six straight days of gains, its longest winning streak since late October and finished the week up 1.8% at 33,978.08.

The S&P ended the week up 2.5% and the tech heavy Nasdaq scored its fourth straight week of gains, climbing 4.3%.

#### **Treasuries**

Treasury yields were mixed on the week with the 2- and 10- year yields posting their largest weekly gains since 30 December but the 30-year bond yield falling 2.3 basis points.

The 2-year note yield remains above 4% despite the drift lower in yields since the start of the year.

### Dollar

Despite the battle over the debt ceiling in the US and dollar index finished the week unchanged.

#### Gold

Gold logged its sixth straight week of gains, with the precious metal closing 0.4% higher for the week.

## **Crude Oil**

US Oil prices ended the week below \$80.00 a barrel in front of next week's OPEC+ meeting. WTI lost 2.4% in the week and Brent fell 1.1%.
