# **U.S. Equities**

The S&P 500 snapped a three-week losing streak. The Dow reversed a four-week down trend, as Investors interpreted recent economic releases as positive signs for the economy.

The Dow climbed 1.8%, the S&P advanced 1.9 and the Nasdaq led the charge up 2.6% for the week.

## **Treasuries**

The 10-year Treasury yield finished the week below 4% as buyers jumped back into the Treasury market.

Yields were mixed. The yield on the 2-year Treasury note finished the week 5.6 basis points higher for its sixth straight week of gains. The 10-year note yield climbed 1.4 basis points this week, also recording a sixth straight week of gains but the yield on the 30-year bond fell 5.1 basis points.

### Dollar

After a strong advance last week, the ICE U.S. Dollar Index fell 0.4% this week on profit taking.

#### Gold

The price of gold scored its first weekly gain in five weeks, rising 2.06% over the five trading sessions.

# OIL

Oil prices rallied on optimism over Chinese demand. West Texas Intermediate rose 4.4% and Brent climbed 3.6% for the week.
