

## WEEKLY COMMENTARY 03.25.2023

## **U.S. Equities**

Despite continued worries about the financial sector, the Dow Jones snapped a two-week losing streak while the S&P 500 and Nasdaq booked back-to back weekly gains.

The Dow rose 1.2% to 32,237.53, the S&P climbed 1.4% to 3,970.99 and the Nasdaq advanced 1.7% to 11,823.96 for the five trading sessions. Keep an eye on the European banking sector as Deutsche Bank shares were under pressure Friday.

#### Treasuries

Treasury bond performance was mixed last week with the yields on the short end falling while the yield on the long bond moved higher, flattening the curve.

The 2-year note yield dipped 6.9 basis points and the 10-year note yield fell 1.6 basis points on the week. The 30-year bond rose 4.2 basis points, posting its largest weekly gain since the week of 24 February.

#### Dollar

Although the US Dollar index did finish the week lower, it bounced off the support level of 102 as investors took shelter in the haven currency headed into the weekend.

## Gold

Gold prices recorded a fourth straight week of gains but failed to hold the technical resistance level of \$2,000.00 an ounce. The precious metal was up 0.5% for the week.

## Oil

Oil prices are facing the uncertainty of an economic slowdown as global economies work their way through the current banking crisis.

WTI saw some profit taking on Friday but posted a weekly gain of 3.5% while Brent rose 2.8% on the week.
