U.S. Equities

A week of mixed signals left the major US averages slightly lower. Both the services and manufacturing PMIs came in hotter than expected while the index of leading economic indicators fell amid mixed Q1 earnings reports.

On the week, the Dow Jones fell 0.2% to 33,808.96, the S&P 500 slipped 0.1% to 4,133.52 and the Nasdaq shed 0.4% to 12,072.46.

Treasuries

Treasury yields finished higher for the second straight week. The 2-year Treasury yields rose 8.5 basis points, the 10-year note advanced 4.9 basis points and the 30-year long bond climbed by 3.8 basis points. The 2-year note yield ended near 4.2%

Dollar

The US Dollar Index faded into Friday's close but still posted a slight gain for the week.

Gold

After a three-week advance in prices, Gold closed lower on profit taking. For the week the precious metal fell 1.3% closing below \$2,000 an ounce.

Oil

Oil prices fell for the first time in five weeks as traders worried about a pending slowdown of the global economy. Both WTI and Brent posted their low closing price for April, down 5.5% and 8.3% respectively.
