## **U.S. Equities**

US stocks recovered some of their weekly losses on Friday after a stronger than expected jobs report cooled recession fears.

On the week, the Dow Jones fell 1.2% to 33,674.38 the S&P 500 slipped 0.8% to 4,136.25 but the Nasdaq posted a 0.1% gain, closing at 12,235.41.

#### **Treasuries**

Treasury yields endured another volatile week with the yields on the 2- and 10-year notes falling for a second straight week.

The 2-year Treasury yield declined by 14.4 basis points; the 10-year note yield fell by less than 1 basis point while the 30-year bond yield climbed 8.5 basis points this week.

## Dollar

The dollar index moved lower against a basket of currencies last week.

#### Gold

Gold prices reached their highest settlement since August 2020 and posted a 1.3% gain for the week.

#### Oil

Both WTI and Brent posted losses on the week as data out of China suggested demand was slowing. WTI fell 7.1% and Brent dipped 6.3% on the week.
