U.S. Equities

US equity markets were mixed last week with the Nasdaq posting its second straight week of gains while the Dow and S&P recording back-to-back weekly losses.

The Dow and S&P were dragged lower by Disney, who reported weaker than expected streaming numbers. The Dow Jones fell 1.1%, the S&P 500 dipped 0.3% to 4,124.08 but the Nasdaq rose 0.4% on the week.

Treasuries

The short end of the Treasury curve spiked after a meeting on the US debt ceiling between President Biden and congressional leaders was postponed.

The 2-year note yields rose 8.2 basis points, the 10-year note yields climbed 1.6 basis points and the 30-year bond yield advanced 1.5 basis points this week.

Dollar

The dollar index rallied last week on a flight to safety as concerns over the debt ceiling deadline and a US default.

Gold

Gold prices recorded a loss for the week but held above the psychologically important level of \$2,000.00 an ounce. The rally in gold seems to have stalled around current levels.

Oil

Oil prices fell for the fourth consecutive week as fears of a global recession dominated markets. WTI prices dropped 1.8% and Brent 1.5% in the week.
