

WEEKLY COMMENTARY 06.17.2023

U.S. Equities

The S&P 500 posted its longest weekly winning streak since November of 2021. All three US averages recorded strong weekly performance after the Federal reserve announced a "pause" in interest rate hikes on Wednesday.

The Dow Jones climbed 1.2% to 34,299.12, the S&P 500 advanced 2.6% to 4,409.59 and the Nasdaq Composite surged 3.2% to 13,689.57. US markets are closed Monday for the Juneteenth Holiday.

Treasuries

Despite the pause, the Federal Reserve took in hiking interest rates. The 2-year Treasury yield climbed to its highest level since 9 March, scoring an 11.6 basis point rise last week.

The 10-year note yield rose 2.4 basis points, but the 30-year bond yield fell 3.1 basis points.

Dollar

Following the Fed's decision, the US dollar traded lower, posting a 1.2% decline in the week.

Gold

Gold prices touched their lowest intraday level since May last week and slipped 0.3% over the last five trading days.

Oil

Oil prices rose in the week with West Texas Intermediate prices climbing 2.3% and Brent prices rising 2.4%. Crude prices broke a two-week losing streak. Peter Conniff Head Trader
