U.S. Equities

US stocks moved lower in the first week of August after ratings agency Fitch downgraded US credit from AAA to AA+.

On the week the Dow Jones fell 1.1% to 35,065.62, the S&P 500 slipped 2.3% to 4,478.03 and the Nasdaq declined 2.9% to 13,909.24.

Treasuries

This week the 10- and 30- year Treasury yields hit their highest levels since November 2022 on signs the US economy is still growing at a solid clip.

Friday's jobs number was the only disappointment in a packed week of data releases.

On the week, the 2-year note yield dipped 10.4 basis points, but the 10-year rate rose 9.2 basis points and the 30-year bond yield climbed 18.6 basis points.

Dollar

The US dollar was volatile over the last five trading sessions but ended the week higher.

Gold

Friday's weak jobless report snapped a three-day losing streak for gold but was not enough to reverse the weekly downtrend in the precious metal. Gold prices were down 1.2% on the week.

Oil

Saudi Arabia and Russia confirmed they would extend production cuts through September pushing both WTI and Brent prices to their highest levels since April 12th. WTI posted a 2.5% gain while Brent was up 1.9% this week.
