

# WEEKLY COMMENTARY

# **U.S. Equities**

Stocks struggled through their worst week since March as the Federal Reserve reminded markets there is still work to be done in the fight against inflation. The S&P 500 and Nasdaq each logged a third-straight weekly decline as rising bond yields rocked equities in the wake of the Federal Reserve meeting on Wednesday. For the week, the Dow fell 1.9%, the S&P 500 dropped 2.9% and the Nasdaq Composite slumped 3.6%.

### **Treasuries**

Treasury yields advanced for the third consecutive week as Fed Chairman Powell suggested rates would remain higher for longer. The yield on the 2-year Treasury note climbed 9.3 basis points to settle at its highest level since 2006. The 10-year note yield advanced 11.7 basis points and the 30-year bond yield added 11.1 basis points.

## Dollar

The US Dollar Index traded at its highest level since March 2023 on Friday, finishing the week up 0.2%. The DXY has now been up for 10 straight weeks, its longest such streak since October of 2014.

#### Gold

After a volatile week of trading gold prices closed out the week about where they started.

## Oil

It was a strange week for oil prices with WTI ending higher and Brent moving lower. US prices climbed on news Russia would ban some gasoline and diesel exports, while the global benchmark drifted down 0.7%. over the five trading days.
