## **U.S. Equities**

US stocks recorded a third straight week of gains as the "soft landing" thesis continues to gain momentum. It is too early to confirm a soft landing but the recent drop in bond yields seems to have given the cash on the sidelines a reason to move into equities.

For the week, the Dow Jones gained 1.9%, the S&P 500 jumped 2.2% and the Nasdaq Composite advanced 2.4%. In the past three weeks, the Dow gained 7.8%, the S&P 500 rose 9.6% and the Nasdaq jumped 11.7%.

#### **Treasuries**

Treasury yields drifted lower again this week as recent data releases showed a US economy that is slowing. The 2-year Treasury note yield fell 15.3 basis points on the week.

The 10-year bond dipped 18.6 basis points and the 30-year bond slid 13.6 basis points. The 30-year Treasury yield fell for the fourth week in a row. Logging its biggest four-week drop since Dec. 16, 2022.

### Dollar

The US Dollar Index closed at its lowest level since September 1.

#### Gold

Gold regained its upward momentum, scoring a more than 2% gain on the week. The yellow metal is being supported by the expectation that the Federal Reserve is done hiking rates.

### Oil

Oil prices slipped into bear territory, notching a fourth straight week of losses as oil traders continue to worry about an economic slowdown. Rumors of further production cuts by OPEC+ helped stem the selling pressure on Friday.
