U.S. Equities

Stocks reacting to the Federal Reserves "dot plot" changes and rallied last week. The Dow Jones rose 2.9% in the week, reaching a record high, the S&P 500 advanced 2.5% and the Nasdaq Composite climbed 2.85%.

Nearly all the S&P 500's 11 sectors finished with gains this week, while small-capitalization stocks saw a stronger rally than large-cap equities.

Treasuries

Treasury yields closed lower on the week as the Federal Reserve pivoted to a more dovish stance.

The 2-year yield dropped 27 basis points in the week, the 10-year note yield fell 31.7 basis points and the 30-year yield slid 29.9 basis points. The 10- and 30- year yields posted their biggest weekly declines in a year, with 10-year yield now below 4%.

Dollar

The US dollar index moved lower again this week as government bond yields retreated.

Gold

Gold prices rallied mid-week and closed out the week with gains. The yellow metal finished the week above \$2,030.00 an ounce.

Oil

OIL prices rose for the first time in eight weeks as geopolitical concerns in the Red Sea drove prices higher. WTI closed higher by 0.3% and Brent was up 0.9% for the week.
