

WEEKLY COMMENTARY 02.03.2024

U.S. Equities

Even though the Federal Reserve suggested rate cuts may not be as close at hand as some investors thought and tensions in the Middle East continued to rise, all three major US averages posted gains with the Dow Jones and S&P hitting record highs. The S&P 500 gained 1.4% to close at 4958 a record, the Dow climbed 1.4% to 38,654 also a record and the Nasdaq advanced 1.1% on the week.

Treasuries

Treasury yields were mixed in this week's trading with the 10-year yield marking its biggest one day jump since 2022 after a very strong US jobs report Friday. The 2-year yield finished the week up less than 1%, the 10-year fell by 12.9 basis points and the 30-year yield dropped 16.2 basis points.

Dollar

The US dollar rose to a seven-week high as expectations of rate cuts have been pushed out to later in the year following the FOMC meeting this week.

Gold

Gold prices recorded a more than half a percent gain in volatile week of trading.

Oil

Oil prices posted their biggest weekly fall since October as reports of a ceasefire and hostage deal in the Israel-Hamas war surfaced. WTI fell 7.4% and Brent dropped 6.8% for the week. Peter Conniff Head Trader
