

# WEEKLY COMMENTARY 09.03.2024

### **U.S. Equities**

All three major US averages posted losses for the weak as traders took profits after a strong run by the S&P 500 and no clear shortterm catalyst to drive markets. For the week, the Dow fell 0.9%, the S&P 500 slipped 0.3% and the technology-heavy Nasdaq dropped 1.2%. The Dow booked its biggest weekly percentage decline since October.

## **T**reasuries

Treasury yields ended the week lower after Federal Reserve Chairman Powell continued to articulate the FOMC was data depended during his Congressional testimony only to have Friday's jobs report paint a mixed picture with the unemployment rate rising as the economy created more jobs than expected. For the week the 2-year yield fell 4.7 basis points, the 10-year yield declined 9.2 basis points and the 30-year yield slipped 6.5 basis points.

## Dollar

The US Dollar lost nearly 1.4% in the week as a mixed jobs report of Friday suggested the Fed may cut rates sooner than expected.

# Gold

Gold surged to a new record high on Friday, approaching \$2,200 an ounce after the latest jobs report reinforced the view that interest rate cuts may come as soon as June.

### Oil

The week was busy for oil markets amid the OPEC+ cuts extension and offsetting economic results from the US and China. WTI ended the weekly lower by 2.45% while Brent fell 1.76%.
