

WEEKLY COMMENTARY 03.30.2024

U.S. Equities

The US stock indices finished the holiday shortened week with mixed results. The S&P 500 added 0.1%, hitting a new high, the Dow Jones gained 47 points, while the Nasdaq ended 0.1% lower. However, the US stocks posted strong Q1 results with the S&P 500 up 10.2% for the first three months of the year.

Treasuries

Treasury yields drifted lower in the week as the bond market awaited the release of the all-important February PCE numbers on Friday. With markets closed we will have to wait until Monday to see how investors react to a headline number that was in line with expectations but contained upward revisions to core PCE. Yields on U.S. government debt finished the first quarter with their largest jumps since September for 10- and 30-year Treasury and since June for 2-year Treasury.

Dollar

The US Dollar Index recorded a second week of gains and closed the quarter nearly 3% higher as investors pushed out their timing for rate cuts.

GOLD

Gold prices surged more than 2.2% this week with the four-day rally now within striking distance of fresh record highs.

Oil

Oil prices moved lower this week after reaching four-month highs last week but recorded solid gains for the month and quarter.

Please note these numbers are based on 5 trading days and not the holiday shortened week that just passed.
