# **U.S.** Equities

The three major US indices all fell on the week with the Dow Jones leading the way as investors heard hawkish comments from the Fed. The timing of the much-anticipated Fed rate cut seems to be moving later into the year. On the week, the S&P 500 slipped 0.7%, the Nasdaq dropped 0.5% and the Dow fell by more than 2%. The market will soon focus its attention on Q1 earnings which begin late next week.

## **Treasuries**

A strong jobs report on Friday lifted the 10- and 30-year Treasury bond rates to their highest levels since late November. The 2-year note yield jumped 11.2 basis points, the 10-year note yield surged 18.5 basis points and the 30-year bond rate advanced 19.4 basis points.

## Dollar

The US Dollar Index did little during a week of Fed speak and data releases. The dollar finished the week slightly lower.

## GOLD

Gold prices reached their thirteenth record high of the year as geopolitical tensions and central bank demand helped lift the price of the yellow metal. Gold futures for June delivery closed at \$2,345.00 an ounce on Friday.

#### Oil

Tighter global supply numbers and increasing tensions between Israel and Iran pushed crude prices to their highest levels since October. WTI advanced 4.5% in the week while Brent climbed 4.8%.
