

WEEKLY COMMENTARY 04.13.2024

U.S. Equities

It was a tough week for stocks as higher inflation data and a shaky start to Q1 earnings put pressure on equity valuations. All three major US averages fell in the week with the Nasdaq posting the best relative performance. The S&P 500 remained above 5100 which is minor support.

Treasuries

Signs of rising inflation helped push the 10- and 30-year Treasury yields to their best two-week performance since October. The 2-year Treasury note climbed 15.2 basis points on the week, the 10-year note was up 12.2 basis points and the 30-year bond advanced 7.2 basis points.

Dollar

The US Dollar index reached its highest levels since November boosted by geopolitical tensions and expectations that the Fed will maintain rates higher for longer.

GOLD

Gold hit a record high on Friday and advanced by around 3.4% over the week as the haven bid outweighed a possible delay in interest rate hikes. Gold is currently around \$2,410.00 per ounce.

Oil

Crude futures finished higher on Friday, with the risk of an Iranian attack on Israel leading prices for U.S. and global benchmark oil to their highest intraday levels in about six months. However, crude finished the week lower with West Texas Intermediate crude down 1.4% and Brent lower by 3.2% in the week.
