

# WEEKLY COMMENTARY 05.09.2025

# **U.S. Equities**

The momentum in US stocks stalled this week despite a trade deal with the UK. The three major averages ended the week lower as trade talk between China and US are set to begin this weekend. The Dow Jones posted a weekly decline of 0.2%, the S&P 500 fell 0.7% and the Nasdaq Composite lost 0.6%.

# **Treasuries**

Treasury yields moved higher for the week with the 2-,10- and 30-year yields up for a second week in a row. At the conclusion of the Fed meeting on Wednesday, Federal Reserve Chair Jerome Powell signaled a more hawkish tone, pushing back against the notion of a preemptive rate cut in response to trade risks. The benchmark 10-year currently sits around 4.38%.

## Dollar

The US dollar index posted a third straight week of gains, up 0.6% over the five trading sessions.

## GOLD

Gold recorded a weekly gain and remains near record high levels. Optimism surrounding potential US trade agreements slowed the advance of the yellow metal.

### Oil

Oil prices increased by over 4% this week in the wake of a trade agreement between the US and UK. Despite positive news, caution persists as OPEC+ plans to ramp up production, potentially weighing on prices. Additionally, tighter US sanctions on Iran may restrict supply, injecting fresh uncertainty into the market.
