

WEEKLY COMMENTARY 05.30.2025

U.S. Equities

Monday's holiday must have given markets a rest from the trade war it needed as all three major averages closed out a strong month with strong weekly performance. The S&P 500 rose 1.88%, the Dow Jones climbed 1.6% and the Nasdaq increased by 1.94% as President Trump backed off some of his largest tariffs and the US Court of International Trade challenged the legal basis for most of them. May saw the S&P 500 and Nasdaq post their biggest monthly gains since 2023.

Treasuries

Treasury yields fell this week, with the 2-year and 10-year Treasury notes snapping a four-week streak of rising yields. Yields came under pressure after a shrinking trade deficit, a positive PCE inflation report and solid consumer income numbers, suggest the Fed will remain on hold. Longer dated maturities held up better than short-dated maturities.

Dollar

The US dollar index finished a choppy week slightly higher after a court ruling muddied the water of tariff policy.

GOLD

Gold prices retreated this week as strong economic data dampened demand for safety of the yellow metal. New data showed that personal income in the US rose much more than expected in April, while expenditure and prices rose in line with expectations.

Oil

Oil prices moved lower this week as market participants looked ahead to a meeting of OPEC+ this weekend, where the group is expected to announce production hikes for July. WTI and Brent slid by over 1%.

Please note the numbers below are based on the last five-day trading sessions, not the holiday shortened four-day week.
