07.11.2025

## U.S. Equities

U.S. stocks and government bonds were caught in a selloff on Friday, as President Trump's threats of new tariffs against a host of U.S. trade partners unnerved investors. All three major stock indices finished the week lower with the Dow Jones falling more than 1% for the five trading sessions.

## Treasuries

US Treasury yields rose in the week despite strong demand in earlier sessions. While bond investors continue to price in two interest rate cuts by the Fed later this year, solid economic data suggests the Fed may remain on hold

## Dollar

The US dollar index posted a 1% gain for the week as trade tensions and monetary policy helped support the greenback

## GOLD

Gold prices gained for the fourth week of the last six as President Trump threatened 35% tariffs on Canadian goods starting 1 August and signaled plans for 15–20% blanket tariffs on most other trade partners. The yellow metal gained 0.8% in the week.

## Oil

Oil prices rose over the week as data from the international Energy Agency suggested that summer travel and power generation are currently boosting demand. On the week, WTI climbed more than 2% and Brent prices advanced more than 3%. Slowing growth projections and trade battles still overhang the oil market.
