U.S. Equities

All three US indices recorded weekly gains with the Dow ending the week with its first record close of 2025. The rally was triggered by the highly anticipated speech given by Fed Chair Powell at the Fed's summer symposium. Powell's remarks solidified expectations that the Fed will cut interest rates by a quarter-point when the central bank's policymaking arm meets on 16 -17 September.

Treasuries

Treasury yield fell significantly on Friday after Powell's comments. The benchmark 10-year bond yield closed out the week at 4.25%. Most of the pressure on yields was in the short end of the curve but the direction of yield on all three maturities was lower.

Dollar

The US dollar index fell on Friday after the Fed Chair suggested rates might be headed lower in September lessening demand for the greenback. For the week the index was unchanged, following two weeks of declines.

GOLD

Gold prices posted a gain of around 1% on the week but remain within the trading range that began in April when prices of the yellow metal reached record highs.

Oil

Crude oil prices posted a weekly gain for the first time in three weeks. Uncertainty remains around negotiations to end the war in Ukraine but US crude inventories fell, offsetting any potential increase in supply a truce might bring. WTI and Brent were up 2.9% and 3% respectively.
