U.S. Equities

For a week heavy in economic releases and full of Fed speak the major US averages did little. The rally that began in April seems to be losing steam as we approach October. For the week, the S&P 500 lost 0.3%, the Nasdaq fell 0.7%, while the Dow Jones was unchanged. Even with the dip this week the S&P 500 remains above 6600.

Treasuries

A series of solid economic reports this week helped Treasury yields to rebound from last week's five-month lows. Interest rate futures continued to reflect expectations that the FOMC will deliver a second consecutive rate cut in October. The 10-year note yield ended the week at 4.17%.

Dollar

This week tempered expectations for aggressive rate cuts kept the US dollar Index near three-week highs.

GOLD

Gold closed the week near record levels but did little over the course of the week, posting a 0.61% gain.

Oil

Oil prices rebounded as continued Ukrainian strikes against Russian oil facilities and the possibility of further sanctions against Russia raise supply constraint concerns. WTI climbed 5.3% on a weekly basis and Brent rose more than 4.6%.
