## **U.S.** Equities

What was shaping up to be another strong week for US equities was unwound on Friday when President Trump rattled markets with threats of a "massive" tariff hike on Chinese goods and suggested he might cancel his upcoming meeting with Chinese President Xi Jinping. The President's comments stem from actions China has taken recently in the rare earths market. For the week, the S&P 500 was down 2.4%, the Nasdaq dropped 2.5%, while the Dow lost over 2.7%.

### **Treasuries**

Treasury yields reversed direction on Friday giving up any gains they had made for the week as investors moved into government bonds for safety. The 10-year yield closed the week at 4.06%, its lowest level in three weeks. The US government remains shutdown with neither party seeming to budge on their demands.

## **Dollar**

The US dollar index posted a gain of 1% on the week as political uncertainty in France and Japan weighed on the Euro.

#### GOLD

Despite a ceasefire agreement in Gaza, gold posted an eighth straight week of gains supported by slowing global growth, persistent inflation, and diversification away from US assets and the dollar.

#### Oil

The potential escalation of trade tensions between the US and China and bearish sentiment from OPEC pressured oil prices this week. WTI and Brent fell by over 4% in the last five trading days.
