## U.S. Equities

U.S. stocks struggled for direction as the big banks kicked off the first week of Q4 2025 earnings season. Uncertainty surrounding the next Fed Chair and geopolitical tension both at home and abroad also impacted the US markets. For the week, the S&P 500 fell 0.4%, the Nasdaq dropped 0.7%, and the Dow Jones slipped 0.3%.

## Treasuries

Treasury yields climbed in the week reaching their highest levels in four months. A criminal probe by the Department of Justice into the Fed, employment data suggesting the labor market may be on more stable ground than thought and rising geopolitical tensions all helped to lift yields. The benchmark 10-year yield closed the week at 4.22%.

## Dollar

The dollar index posted a third consecutive weekly gain as strong US economic data tempered expectations for additional Federal Reserve interest rate cuts.

## Gold

Gold prices remain near record highs and posted weekly gains as President Trump backed away from earlier threats against Iran and US economic data remained solid suggesting interest rates will remain at current levels longer than the market had anticipated.

## Oil

Oil prices hit multi-month highs earlier in the week after protests in Iran and the threat of potential military action raised concerns over disruptions to the country's crude output. West Texas Intermediate climbed half a percent and Brent ended the week 1% higher.
