U.S. Equities

Another crazy week for US equities ended with the Dow Jones eclipsing 50,000 for the first time. The results were not as positive for the S&P 500 and Nasdaq as big tech remained under pressure. The Dow Jones closed 2.5% higher in the week while the S&P 500 dipped 0.1% and Nasdaq fell 1.8%.

Treasuries

It was another volatile week for US government bonds with yields falling across all maturities but remaining within recent trading ranges. The risk-off trade of Thursday was reversed on Friday as consumer confidence was reported higher in February. Looking ahead, investors will focus on the delayed US jobs report and the upcoming CPI release next week for further clues on economic momentum. This week the ECB left rates unchanged as expected.

Dollar

The dollar index closed 0.9% higher for the week and remained near a two-week high. Investors bought the dollar as risk assets came under pressure this week.

Gold

Gold futures finished a volatile week higher for the seventh time in the past nine weeks. Despite the volatility seen in both gold and silver in recent trading sessions, the momentum for both appears to be to the upside.

Oil

Oil prices fell for the first time in seven weeks. A positive start to nuclear talks between the US and Iran lessened recent concerns over supply disruptions. WTI declined by 2.6% and Brent fell 2.0% in the week.
